

## **WEBSITE TERMS AND CONDITIONS OF USE**

### **1. About the Website**

- (a) Welcome to The Plan Management People (**Website**). The Website NDIS Plan Management Services (**Services**).
- (b) The Website is operated by Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People(ACN 109983842). Access to and use of the Website, or any of its associated Products or Services, is provided by Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People. Please read these terms and conditions (**Terms**) carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.
- (c) Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

### **2. Acceptance of the Terms**

- (a) You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People in the user interface.

### **3. Registration to use the Services**

- (a) In order to access the Services, you must first register for an account through the Website (**Account**).
- (b) As part of the registration process, or as part of your continued use of the Services, you may be required to provide personal information about yourself (such as identification or contact details), including:
  - (i) Email address
  - (ii) Preferred username
  - (iii) Mailing address
  - (iv) Telephone number
  - (v) Password
  - (vi) NDIS registration number

- (b) Subject to this clause, and to the extent permitted by law:
  - (i) all terms, guarantees, warranties, representations or conditions which are not expressly stated in the Terms are excluded; and
  - (ii) Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People will not be liable for any special, indirect or consequential loss or damage (unless such loss or damage is reasonably foreseeable resulting from our failure to meet an applicable Consumer Guarantee), loss of profit or opportunity, or damage to goodwill arising out of or in connection with the Services or these Terms (including as a result of not being able to use the Services or the late supply of the Services), whether at common law, under contract, tort (including negligence), in equity, pursuant to statute or otherwise.

## **11. Termination of Contract**

- (a) The Terms will continue to apply until terminated by either you or by Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People as set out below.
- (b) If you want to terminate the Terms, you may do so by:
  - (i) providing Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People with days' notice of your intention to terminate; and
  - (ii) closing your accounts for all of the services which you use, where Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People has made this option available to you.

Your notice should be sent, in writing, to Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People via the 'Contact Us' link on our homepage.

- (c) Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People may at any time, terminate the Terms with you if:
  - (i) you have breached any provision of the Terms or intend to breach any provision;
  - (ii) Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People is required to do so by law;
  - (iii) the provision of the Services to you by Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People is, in the opinion of Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People, no longer commercially viable.
- (d) Subject to local applicable laws, Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People reserves the right to discontinue or cancel your membership at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Website or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People's name or reputation or violates the rights of those of another party.

- (i) all actions, suits, claims, demands, liabilities, costs, expenses, loss and damage (including legal fees on a full indemnity basis) incurred, suffered or arising out of or in connection with your content;
- (ii) any direct or indirect consequences of you accessing, using or transacting on the Website or attempts to do so; and/or
- (iii) any breach of the Terms.

### 13. Dispute Resolution

(a) **Compulsory:**

If a dispute arises out of or relates to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).

(b) **Notice:**

A party to the Terms claiming a dispute (**Dispute**) has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.

(c) **Resolution:**

On receipt of that notice (**Notice**) by that other party, the parties to the Terms (**Parties**) must:

- (i) Within \_\_\_\_\_ days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- (ii) If for any reason whatsoever, \_\_\_\_\_ days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon selection of a mediator or request that an appropriate mediator be appointed by the President of the \_\_\_\_\_ or his or her nominee;
- (iii) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a pre-condition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;
- (iv) The mediation will be held in \_\_\_\_\_, Australia.

(d) **Confidential:**

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible,

must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

**(e) Termination of Mediation:**

If 30 days have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation and the mediator must do so.

#### **14. Venue and Jurisdiction**

The Services offered by Bradycorp Pty Ltd ATF The B&B Trust TA The Plan Management People is intended to be viewed by residents of Australia. In the event of any dispute arising out of or in relation to the Website, you agree that the exclusive venue for resolving any dispute shall be in the courts of \_\_\_\_\_, Australia.

#### **15. Governing Law**

Both parties confirm and declare that the provisions of the Terms are fair and reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of inequality or bargaining power or general grounds of restraint of trade.

#### **17. Severance**

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
